Transportation network companies are prohibited from conducting activities within the city limits under AS 28.23, (the Transportation Network Companies Act) or otherwise. For purposes of this section "transportation network company" or "TNC" means any person or entity that uses a digital network to connect TNC riders with TNC drivers who provide prearranged rides. As used in this section "prearranged rides" does not include car pool or van pool arrangements or transportation using a public vehicle for which a taxicab certificate of public convenience or public vehicle certificate has been issued by the city.</p> <p>AS 29.35.148(c) provides that a municipality may by ordinance ratified by the voters at a regular municipal election prohibit transportation network companies from conducting activities under AS 28.23 within the municipality.</p> <p>Should Ordinance No. 17-1855 which prohibits the operation of transportation network companies within the city limits of the City of Ketchikan be ratified?</p>
