# General Aviation Pilot Unescorted Access Acknowledgement

I understand that my access to the General Aviation (GA) is via the Fixed Base Operator (FBO), currently AERO Services, and that my operational need for the Airport Operations Area (AOA) is the shortest direct route, while avoiding obstacles and aircraft on the ramp, from the FBO to my plane.

I understand that I am responsible for ensuring that anyone I escort stays within my control while within the restricted area.

I understand that I am responsible for the safety of anyone I escort while transiting from the FBO to my plane and back.

I understand that I do not have driving privileges with my GA Pilot AOA badge. Should I need to drive a vehicle to my plane, I will need the FBO (AERO Services) to provide a vehicle escort for me and that vehicle escort shall remain with me as long as my vehicle is within the restricted area.

I understand that my access is limited to the airports operational hours and I am responsible for knowing what those hours are, to include when the last ferry of the day departs.

I understand that should I have any questions or concerns regarding security or safety issues at the airport, that I will contact the Airport Police or the Airport Security Coordinator at 225-6800 as soon as possible.
